Second Amendment of the By-Laws

WHEREAS, Article XIV of the By-Laws of the Homeowners Association of West Fork, Inc. allows the By-Laws of the Association to be amended by vote of a majority of a quorum of members present in person or by proxy at a regular or special meeting of members of the Association;

WHEREAS, there is a need to increase the participation of members in the governance of the Association;

WHEREAS, a majority of a quorum of members present at the February 10, 2011 regular annual meeting of the Association voted to approve an increase in the number of directors of the Association from three (3) to five (5), to implement the increase in Board membership in an orderly manner, and to approve other clarifying changes in the By-Laws;

NOW THEREFORE, Article IV, Board of Directors, of the Association By-Laws is changed as follows:

Section 1. <u>Number.</u> Commencing at the first regular or special meeting of the Board of Directors following the regular annual meeting of members in 2012, the affairs of the Association shall be managed by a Board of five (5) Directors, who only shall be members of the Association.

Section 2. <u>Term of Office</u> At the regular annual meeting of the members in 2012, one additional director shall be elected for a term of one year and one additional director shall be elected for a term of two years. Upon election by the members at each annual meeting thereafter, each director shall serve for a term of three years. Commencing in 2011, each director, whether elected or appointed, shall be limited to six years of consecutive service. After an interval of one year, past directors are eligible for reelection or reappointment.

New directors shall take office at the first regular or special meeting of the Board of Directors following their election. Retiring directors will hold office until the first regular or special meeting of the Board of Directors following the expiration of their term of office.
